## Accounting Pathway (FCAP)



### FCAP BENEFITS:

- Earn the Business Administration Associate in Science Degree for Transfer 2.0
- Guaranteed transfer to CSUF into the Business Administration, Accounting Concentration, B.A.
- Consideration into CSUF's 1-year master's degrees in either Taxation or Accounting (qualifying the student to sit for the CPA exam).
- A clearly-defined academic timeline.
- Dedicated Accounting Classes (Acct 101AF and/or Acct 101BF). Acct 101AF and Acct 101BF are the only dedicated courses for the program.
- Business Skills Workshops.
- Mentoring Program.
- Membership into nationally recognized clubs and organizations such as the CSUF Accounting Society while still at FC (Firms recruit from CSUF Accounting Society).



### FCAP ADMISSION REQUIREMENTS:

- Completed FCAP Application form.
- Students must take ACCT 101BF with the FCAP cohort. Therefore, students with prior completion of ACCT 101BF are not eligible for the program.
- Students may apply to join the program with a cumulative CSU GPA that is below 3.0, however they must earn at least a 3.0 CSU transferable GPA at the time their ADT is completed to receive the guaranteed admission into CSUF Business Administration Bachelors of Arts with the Accounting Concentration.
- Bus 100 or BUS 211 do not need to be completed prior to their 2nd year.
- Meet with a counselor for a comprehensive student educational program plan (SEPP) that reflects the completion of the Business Administration Associates in Science Degree for Transfer (2.0).



### FCAP COMPLETION REQUIREMENTS (TO REMAIN IN THE PROGRAM):

- Complete and apply for the Business Administration Associate in Science Degree for Transfer 2.0 from Fullerton College.
- Earn a cumulative CSU Transferable GPA of at least 3.0 at time of ADT completion. 3.0 GPA is required to remain in the program while at CSUF.
- Full-time enrollment (12 units) fall and spring is encouraged but not required.
- Fully participate in the required co-curricular activities, including tutoring, cohort meetings, Meet the Firms, field trips and other FCAP events – number of events TBD.
- Attain "B" grades or better in ACCT 101AF and ACCT 101BF.
- Must take **ACCT 101BF** at Fullerton College with the program cohort.
- Students do not have to complete the Bus Admin AD-T (2.0) in two years.
- Apply to CSUF using Cal State Apply.

### Q&A:

- **When is the earliest a student can begin the FCAP program?** Students can enroll prior to taking ACCT 101AF and ACCT 101BF. **Where can a student get the application?** (See attached, or visit Career Education Resources Website under Accounting, <https://counseling.fullcoll.edu/ctecounselor/>)
- **Are students accepted for Fall and Spring ACCT 101AF and ACCT 101BF cohorts?** Yes, students will be accepted for Fall and Spring 101A and 101B
- **When is the FCAP application available and due (Fall/Spring)?** The tentative application deadline for Fall 2025 admission will be June 30, 2025. The tentative application deadline for Spring 2026 admission will be mid-January 2026.
- **How do FCAP students apply to CSUF?** Students apply to CSUF for Fall or Spring admission using Cal State Apply. Students do not need to indicate on the application that they are a part of the FCAP program. Logistics of students in the program are manually handled on the back-end. Under campus options, when selecting CSUF, students should also select the option Business Administration: Accounting Concentration.
